1) The City Government of Navotas, through the City Appropriation Ordinance No. 2025-33 (CY-2026 Annual Budget) and City Appropriation Ordinance No. 2025-45 (Utilization of 2026 20% Community Development Fund) intends to apply the sum of

2) The City Government of Navotas now invites bids for above Procurement Project Completion of the Works is required

- LOT 1 – 45 Calendar Days
- LOT 2 – 150 Calendar Days
- LOT 3 – 90 Calendar Days
- LOT 4 – 60 Calendar Days
- LOT 5 – 150 Calendar Days

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)". Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4) Interested bidders may obtain further information from City Government of Navotas – Bids and Awards Committee and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 AM to 5:00 PM.

5) A complete set of Bidding Documents may be acquired by interested bidders on March 16, 2026 from the address below (Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of

7.) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through: (i) manual submission at the office address indicated below on or before April 7, 2026, 12:00 noon. Late bids shall not be accepted.

8.) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9.) Bid opening shall be on April 7, 2026, 2:00 PM at Mayor's Conference Room, Fourth Floor, Navotas City Hall Building. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

The Head of the Procuring Entity (HoPE) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
