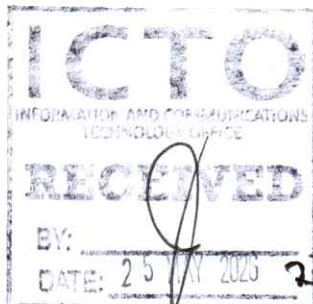

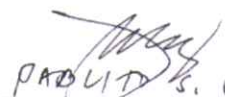

This CONTRACT AGREEMENT executed on the 21st day of April 2026 by and between:

JIMENEZ** and **ARNOLD S. BAUTISTA**, hereinafter referred to as "the Supplier".

WITNESSETH:

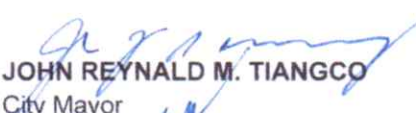
1. **Scope of Work:** The Supplier shall supply and deliver [Goods/Products - Well-Milled Rice 10kg net weight (Packaging: Laminated/Woven Sacks with Project Branding and NOT FOR SALE) Inclusive of delivery fee and unloading to the Entity. Detailed specifications and quantity are in the attached Purchase Order (Annex A).
2. **Contract Price:** The Entity agrees to pay the Supplier the total amount of **PHP 42,034,920.00 Forty-Two Million Thirty-Four Thousand Nine Hundred Twenty Pesos** hereinafter referred to as "the Contract Price", which is based on a fair pricing mechanism, considering market prices monitored by the DA/DTI and the exclusion of intermediaries.
3. **Delivery Schedule:** Based on Ordering Agreement-Date and Time indicated on Delivery Order Contract.



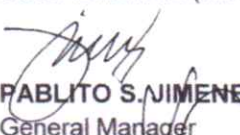
4. **Payment Terms:** Progress Billing shall be processed after every scheduled delivery, supported by an Inspection and Acceptance Report, Delivery Receipts and list of beneficiaries.

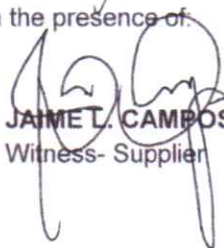
