- 1) The City Government of Navotas, through the Regular Agency Fund intends to apply the sum of FOUR MILLION EIGHT HUNDRED FOURTEEN THOUSAND FIVE HUNDRED NINETY-EIGHT PESOS AND EIGHTY-TWO CENTAVOS (PHP 4,814,598.82) being the Approved Budget for the Contract (ABC) to payments under the contract for REPAIR OF 4 STY 8 CL SCHOOL BUILDING AT TANZA NATIONAL HIGH SCHOOL, BRGY. TANZA 1, NAVOTAS CITY. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The City Government of Navotas now invites bids for REPAIR OF 4STY 8 CL SCHOOL BUILDING AT TANZA NATIONAL HIGH SCHOOL, BRGY. TANZA 1, NAVOTAS CITY is required 90 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR, otherwise known as the "New Government Procurement Act (NGPA)". Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4) Interested bidders may obtain further information from City Government of Navotas - Bids and Awards Committee and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 AM to 5:00 PM.
- 5) A complete set of Bidding Documents may be acquired by interested bidders on, JUNE 25, 2026, at 2:00PM from the address below (Insert if necessary; and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6) The City Government of Navotas - Bids and Awards Committee will hold a Pre-Bid Conference on JULY 03, 2026, 2:00 PM at Mayor's Conference Room, 4/F Navotas City Hall, and/or through video conferencing via Zoom Platform, which shall be open to prospective bidders.
- 7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through: (i) manual submission at the office address indicated below on or before JULY 16, 2026, 12:00 noon. Late bids shall not be accepted.
- 8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
- 9) Bid opening shall be on JULY 16, 2026, 2:00 PM at Mayor's Conference Room, Fourth Floor, Navotas City Hall Building. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
- 10) The Head of the Procuring Entity (HoPE) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
